Welcome

Amy Lee welcomed Paul Rose as a new commission member.

Land Acknowledgement, Opening Reflection, and Prayer

Moon Ja Park gave a land acknowledgement and provided an opening reflection and prayer.

Minutes

Correspondence

There was no correspondence to come to the Commission.

Staff Updates – *Kim Uyede-Kai*

- Korean translation of handbooks has now started. The first two items being translated are the *Pastoral Relations Guidelines for Search and Selection* (50 pages), and *Ministry & Personnel Committees Policies, Procedures and Practices* (28 pages). Those pages also include screen shots of the Church Hub forms that need to be filled in. Translation is being done by Rev. Woon Youm and proofreading will be done by Rev. Julia Yun Jung Kim. They are hoping to have it done by the end of November.
- Staff of Shining Waters and Canadian Shield are following-up with the anti-racism course they did last year. They are starting to work on the book, *Wait is this Racist? A Guide to Becoming an Anti-Racist Church*. They meet every other week for an hour to study a piece of

- the book. It is doing two things building community and trust within the staff team as well as developing anti-racism language and context.
- She recently visited and worshipped with the francophone congregation in Toronto who worship at Downsview United Church. After the service, lay leaders and ministers of the francophone church and Downsview had a conversation.

Seoul Presbytery, Presbyterian Church in the Republic of Korea (PROK) proposal for Partner in Mission

Amy provided some information about PROK; it consists of 28 presbyteries with 1,600 churches and over 300,000 members in South Korea. Seoul Presbytery is one of the 28 presbyteries and has 44 churches affiliated with it. There are four presbyteries in the Seoul district area.

Richard Choe joined the meeting. He gave background and information on the how and why of the PROK visit exchange that took place with Toronto Conference in 2016 and 2017. He gave his insights into the learnings of that time as well as what we could show them and what they could teach us if they visited again.

The current proposal from PROK is to have partner in residence program for one person to come to Canada, to live here for one year and experience the United Church with perhaps three or four congregations so that they have a broad sense of our region; it could include a time at Emmanuel College or a Korean United Church to learn what the Canadian context is. There is one person who has expressed interest in coming. The presbytery was also exploring a partnership of sorts with Shining Waters.

A small task group reporting to the Commission will be formed to oversee what this program would look like. The Commission was asked to think of a church or churches that might be willing to host this person for three or four months at a time. This Commission could look at the person's learning goals and help mentor them.

Richard Choe was thanked and left the meeting.

The task group will start with Amy Lee and Richard Choe and more people will be added.

2022-2023 Budget Planning and Approval

A proposed draft budget was discussed by the Commission (Appendix A).


