## Welcome, check in and prayer

The chairperson welcomed everyone. Diane Matheson-Jimenez gave an acknowledgement of the land, and acknowledged our commitment to being a safe place for all people to gather and participate in our Region. As an opening, Diane shared a video, *Stand Up* by Tracy Cain, in honour of Black History Month, and offered a prayer from *Ancestors and Ancestry: A worship service honouring the histories of our families and our faith*, by Rev. Debbie McMillan.

The chairperson constituted the meeting in the name of Jesus Christ.

#### Agenda

An item on Bala-Port Carling and on Community Ministries was added to the Agenda and the Agenda was then accepted as amended by consensus.

#### **Minutes**

**MOTION** by Amy Lee / Harry Ramsaran that the Minutes of the meetings of the Communities of Faith Commission of Shining Waters Regional Council dated December 15, 2021 be approved as circulated.

#### **Report from Strategic Planning**

The report from the Strategic Planning session held on January 19, 2022 had been circulated. By consensus, there were no errors or omissions noted, and the report was accepted as circulated.

# Correspondence

A letter has been received from St. Andrew's, Toronto regarding the regional council property policy. The letter asked a number of questions including whether there would be a consultative process in the review of the policy.

Jody Maltby reported that this is not the only congregation that has raised either concerns or support regarding the policy.

There was discussion around the idea of a consultative process and the bigger, underlying issue of property ownership.

It was decided to get more information from St. Andrew's, and let them know that the idea of a consultative process will be examined. Chris Bennett agreed to work with Jody Maltby on a regional conversation on property ownership in response to the request for consultation. Jody and Gloria will draft a response to the letter.

#### **Email Votes**

The following decisions were made by email:

- approved the proposed governance structure of Kingsway-Lambton United Church, Toronto, dated November 16, 2021.
- approved the lease between Lansing United Church, Toronto, and United Property Resource Corporation dated December 1, 2021.
- approved the lease between Knob Hill United Church and Scarborough on Ephesus Seventh-Day Adventist Church.
- approve the loan application of Birchcliff Bluffs United Church with Toronto United Church Council (TUCC) through the Toronto Southeast Presbytery Major Capital Fund, dated January 21, 2022, in the amount of \$290,000.

# **Participation in Regional Meeting** – *Jody Maltby*

The Regional Council annual meeting is taking place in May and a team is being put together to be involved in planning the agenda, in particular, educational components. Each Commission is being invited to have someone participate on that team. There was no one from this commission that felt called to participate on the planning team.

# **Community Ministries** – *Jody Maltby*

The Grants and Mission Support Committee is creating a short-term task group to talk about community ministries – Jane-Finch, Davenport-Perth, Regent Park, and Toronto Urban Native Ministries. Members of this commission are invited to be a part of that conversation along with some people from the Social and Ecological Justice Commission and the Intercultural Diversity Commission. It is about building relationship with the community ministries so we can better support them. They need to know what the regional council commitment is around funding for community ministries and what other options there are around funding. Patti Rodgers and Chris Bennett offered to assist in this conversation.

# **Meeting of Equity Leads** – *Gloria Tozek*

Gloria participated in a meeting of Equity Leads on February 8<sup>th</sup>. There are Equity Leads from each Commission now instead of the former Equity Committee. The leads meet and share ideas; endeavour to break down silos that may happen; look at collaborations and partnerships; and assist in communications.

## Follow-up from Strategic Planning – Gloria/Calin/Susie

- Gloria Tozek, Calin Lau and Susie Henderson took the work from the planning session in January and pulled material together to identify key areas and directions.
- deepening connection; encouraging transformation; renew and support leadership were three directions identified.
- they also got some priorities and goals; should the property matter discussed today be included in the goals? It could be under 'renew and support leadership.'
- there was some feedback discussion on the process used at the planning session.
- a poll was used to identify some priorities on the directions; deepening connections was the top one;
- a poll was used for the goals; strengthen connections between communities of faith and the region was the strongest;
- there was discussion around the goals; are there activities that can be done around them? What are the measures to determine if the activity had impact?
- Gloria, Calin and Susie will continue to work on the document around the priorities and goals; there will be some more polls and emails go out to the Commission; a new document will be brought back to the March meeting of the Commission.

# **Appeal Committee** – *Jody Maltby*

Jody explained that when someone wants to appeal a decision made in a community of faith, this commission needs to manage the appeal. Appeals are very well structured within our polity, Section 10 of *The Manual*. The role of the commission is simply to appoint the appeal committee. The committee has authorization to completely deal with the appeal. There is a community of faith that is at this stage of an appeal. Jody has an appeal committee to recommend to the Commission and there is legal counsel advising the committee.

Jody Maltby gave background on this matter.

<u>MOTION</u> by Kevin Logie / Patti Rodgers that the Communities of Faith Commission of Shining Waters Regional Council approve the policy regarding the conducting of reviews of communities of faith.

#### **Community of Faith Updates**

<u>Dewi Sant/Timothy Eaton</u> – *Diane Matheson-Jimenez* 

Dewi Sant is working hard towards their goal of amalgamation with Timothy Eaton; they meet every two weeks and are meeting next week with Jody Maltby and Tim Blair from UPRC; a proposal will come to this Commission next month for feedback on the use of Dewi Sant's funds, and then in April they will have the amalgamation covenant and financial plan come to the commission for approval.

# Alpha Korean – Jody Maltby

Re: name change and binding arbitration agreement. A legal opinion was received. Alpha Korean using the name of Toronto Korean would be in contravention of the arbitration agreement so the commission should not agree to it. If the two congregations

came to a new agreement, that would be permissible. Alpha Korean has reached out to the Omega congregation to have a conversation.

# Bala-Port Carling – *Jody Maltby*

Mediation was set up with Credence & Co. and the Board of Bala-Port Carling decided to not engage in mediation. However, there is still ongoing complaints and conflict in the congregation that needs to be resolved.

**MOTION** by Chris Bennett / Sandra Nottegar that Shining Waters Regional Council,

- 1. Conduct a review of Bala-Port Carling United Church pursuant to section J.4 of The Manual (2022) of The United Church of Canada; and
- 2. Appoint Beth Symes to conduct the review; and
- 3. Request that the Regional Staff Lead contact potential members for a review committee to consider the reviewer's report and make a decision in response to be communicated to the commission for action; and
- 4. Request the Pastoral Relations Minister to arrange pastoral care as needed.

MOTION CARRIED

The commission will appoint the review committee by email vote once the members are confirmed. The Regional Staff Lead will communicate with the community of faith by letter to inform them of the review and will ask the Pastoral Relations Minister to communicate with the community of faith as well and offer a pastoral response.

## **Preaching Conference at Emmanuel** – *Jeffrey Dale*

Emmanuel College is hosting a preaching conference again this year. Previously, Shining Waters supported the conference with a donation. The focus of the conference this year is on intercultural experiences and conversations in preaching. A guest speaker list is in the process of being developed and Jeffrey is a part those conversations. The Commission is being asked for support of the event in the amount of \$200 to go towards one of the guest speakers/workshop leaders and the use of the Shining Waters logo on their promotional material.

**MOTION** by Amy Lee / Harry Ramsaran that the Communities of Faith Commission of Shining Waters Regional Council support the Preaching Conference at Emmanuel College in the amount of \$200 to go towards guest speakers/workshop leaders for the conference.



# **Report from Intentional Interim Ministry Committee** – Diane Matheson-Jimenez

- Jim Keenan, Chair of the Committee, sent a letter of gratitude and blessing to the intentional interim ministers (IIMs) serving in the region which was very well received. From that, there is an interest in the intentional interim ministers gathering and sharing the unique challenges that they face as IIMs
- A video resource would be helpful to give overview of the work of IIMs and to bring people into the work.
- The Committee is mindful of the fact that within the next 6-18 months, many communities of faith will be facing significant transition; one of the ongoing topics for the committee is a recruitment strategy and a way to make better use of the resources they have.

#### **Dewi Sant** – Presentation and Discussion

Lorraine Diaz, Chris Pinnington from Timothy Eaton Memorial UC and Liz Mackenzie and Sheryl Clay from Dewi Sant Welsh UC joined the meeting.

The guests made a presentation on the amalgamation financial plan of Dewi Sant Welsh United Church and Timothy Eaton Memorial Church. The plan summarized the funding required to amalgamate Dewi Sant and Timothy Eaton and effectively implement the shared vision and mission of the amalgamated congregation. The presentation showed the purpose of the plan is to ensure and support a successful amalgamation and to preserve, support and expand the Dewi Sant culture, language/tradition of worship and heritage.

The presentation was brought to the Commission for feedback and discussion, and then the final financials, estimates for property, and covenant plans will come back to this Commission's April meeting. The amalgamation service is planned for June 26<sup>th</sup>.

The guests left the meeting.

The Commission had an opportunity to discuss the presentation. The Commission asked the staff to remind the communities of faith of the regional council policy on the distribution of funds following the sale of property.

# St. Paul's Brampton – recommendation from IIM Committee

Diane Matheson-Jimenez updated the Commission on the intentional interim ministry at St. Paul's Brampton. The intentional interim minister has submitted a request for a change in pastoral relationship. # Activity plan from Direction setting – Gloria/Calin/Susie

Gloria, Calin and Susie met to carry on with following up the strategic planning exercise.

Gloria shared the draft activities plan for the key priority that was identified in the last meeting: Deepening Connection--Strengthen connection between communities of faith and Shining Waters Regional Council.

The Commission affirmed that building the relationship with regional lay representatives is a key component of this direction and it was pointed out that we may be able to collaborate with other Commissions in this endeavor.

The team will meet again to consider next steps and will continue to keep the overall question of strategic directions before us.

# **Collaborative Ministry meeting** – *Diane Matheson-Jimenez*

Diane reported on a meeting she and Susie had with 25 people representing communities of faith northeast of Brampton: Cheltenham, Nobleton-Schomberg, Home, Bradford, and Caldeon East. They had conversation about what they can do together that they can't do on their own. They shared about Rural Connect, talked about sharing ministry personnel, and some of the relationship building that exists. The conversation will continue as there is interest in more intentional relationship building. It is hoped that something more concrete will emerge as trust and relationship is built.

# **Update on Affirming Ministries** – Susie Henderson


- Jeffrey Dale and Susie share the affirming work for the region.

approved the use by Manor Road United Church of up to \$200,000 from Special Gifts Fund which is money from the sale of property to the City of Toronto in 2015, for the oil tank soil remediation project.

In accordance with Shining Waters Regional Council policy, the following decision was made by the Staff Lead;

- Camp Scugog loan with TUCC approved the loan in the am ount of \$50,000 to Lake Scugog Camp from Toronto United Church Council under the following terms and conditions:
  - Date: April 1, 2022Amount: \$50,000
  - Amortization: 10 years
  - First Term (Years 1-5) with an Interest Rate of 0% per annum, the monthly payments to be based on the amortization period of ten (10) years
  - The balance remaining unpaid on the 5<sup>th</sup> anniversary date shall constitute the principal owing for the second term
  - Second Term (Years 6-10) with an Interest Rate of 1% per annum, the amortization period for the calculation of monthly payments will be five (5) years
  - Payments: Monthly Principal and Interest
  - Security: Promissory Note
  - Approvals: Shining Waters Regional Council (TBA) Source of Funds: Sustainable Energy Loan Fund – (SELF)

MOTION by Carolyn Harding / Sandra Nottegar that the Communities of Faith Commission of Shining Waters Regional Council approve the plan of Dewi-Sant Welsh United Church and Timothy Eaton Memorial United Church, for the funds from the sale of property with the understanding that \$3,048,000 is restricted to support Welsh ministry as outlined in the financial plan appended to the Amalgamation Covenant Agreement. The congregation will provide an update every five years demonstrating that the Welsh ministry continues to be active and viable. If the Welsh ministry ceases to function, remaining funds intended to support the ministry will revert to Shining Waters Regional Council to support other regional ethno-specific ministries.

MOTION CARRIED

#### **Bala-Port Carling**

Jody Maltby updated the Commission with an update on the review of Bala-Port Carling.

A review committee needs to be appointed and it is hoped a member of this Commission would be willing to be on the committee. It is estimated the report will be ready near the end of April. The Commission was asked to give it consideration and get back to Jody if willing to sit on the committee.

#### Canada Summer Jobs Program – Jeffrey Dale

Jeffrey reported that he has not heard back from his application to the Canada Summer Jobs program. There is a budget of \$40,000 so there have been commitments made within that budget. The plan is for Shining Waters to have three positions and Canadian Shield Regional Council to have two positions. The positions will be working with communities of faith in the regional councils around camping, summer programming, and guaranteed livable income. There will be some form of hiring summer students once he hears back from Canada Summer Jobs Program.

# Church Closings and Regional Presence – Jody Maltby

Since becoming a regional council, we have not had a presence with congregations that are closing. The Commission members were agreeable to Jody's proposal that when we know a congregation has made the difficult decision to close and they are having their final service, that we offer the invitation to members of this Commission to attend and be a presence, and speak words of closing with them. There was a suggestion that a letter go from the President and the Executive Minister as well.

# **Intercultural Diversity**

Kim Uyede-Kai was unable to join the meeting but updates were distributed in writing prior to the meeting.

#### In-Person meeting/June Meeting



This is a good time to have that conversation more broadly; General Council is interested and maybe some other regions. This Commission has a lot of insight to bring. #### Canada Summer Jobs Program – Jeffrey Dale

#### **Intercultural Diversity Commission Translation project** – *Kim Uyede-Kai*

The first translations will be in Korean since there are five Korean language communities of faith in Shining Waters. Other language translations may follow if required. 



# Results from Lay Reps survey

Chris Bennett and Susie Henderson led the Commission through the results of the recent survey. Insights:

- Dig deeper into why so many congregations have no rep (challenge to fill roles, low priority, disconnection from region)
- Hear the loss of the connection of people knowing each other through Presbytery meetings. Consider a pilot project to begin to repair relationships and invite conversation about issues that churches are facing. Chris and Patti will consider this idea further.
- Noticed that a large number of ethnic and ethnolinguistic communities of faith don't have lay reps. This may speak to the need to be more intentional about how we are in relationship with ethnic communities in the Region.
- Fall forums are one way to reach out

#### Plan for Fall Forums

Susie presented a draft proposal for forums called, *Lay Reps Let's Connect*. Some of the highlights:

- an hour in the evening on perhaps the last Thursday of the month.
- meet and discuss with regional council leadership and come away with a snapshot of the region.
- have a little take-away at the end of each forum, so they are left with something concrete.
- some topics could be: a report back from General Council meeting in summer; online ministry; community ministries; visioning; collaborative ministry; intercultural partnerships etc.

The group felt this was a good plan. We need to leave ourselves some room to be responsive. Susie would set up process and logistical items; someone would need to be present to facilitate/host the evening.

It was decided to go with the first topic on a 'regional council 101' type of forum, and have this be a work in progress, and let it take the shape it needs to.

The group decided to bring this to another commission meeting and then let a smaller group continue with it.

Diane Matheson-Jimenez left the meeting.

## **Draft budget**

Susie Henderson provided a first draft of a commission budget. It was decided to bring this back for discussion at the next commission meeting in September, after commission members have had a time to think about priorities, etc.

Eric Nyarko left the meeting.

# Canada Summer Jobs update – Jeffrey Dale

There have been 18 students that Jeffrey has been supervising which has made for a very busy summer for him; next year he will apply for five students and he will encourage individual churches to hire students as this program allows the engagement of young people which is valuable to churches.

He would like to have a conversation with this commission and the Social and Ecological Justice Commission on youth matters and how we keep the conversations going. It is very important and fulfilling work.

One of the decisions was to have Diane Matheson-Jimenez work with the congregation to develop a five-year plan for the viability of the pastoral charge, and submit a report to the Review Committee by 2023; acknowledged work of the review committee (Islay Scott (chair), Jim Keenan, Carolyn Harding) and appreciation for their offer to remain constituted to continue supporting this congregation.

- St. Paul's Brampton Review
  The Review Committee is doing good work; their meetings are doing information
  gathering right now; they have engaged Credence & Co for resources for St. Paul's
  and next steps will be discerned from their report.
- Korean translation of handbooks and policy
   There are five Korean language congregations in Shining Waters. The Intercultural
   Diversity Commission was asked to do some translation work starting with Korean.
   Two are underway right now: the pastoral relations handbook around search and
   selection, as well as the Policies, Procedures, and Practices handbook. Two

There is a need to have an understanding of the theology of our property policies and decisions. This is more of a national conversation, and this Fall a number of people will be starting the conversation.



# Welcome, constituting the meeting and prayer

Chris Bennett welcomed everyone to the meeting. Dale Hildebrand gave an acknowledgement of the land. Donna Bowman-Woodall led a time of worship. There was a time of introductions.

Joint Commission Conversation - leader, Chris Bennett

#### **Emerging from Pandemic**

Susie Henderson led a facilitated discussion scanning the landscape, taking input from the members under categories of what we have lost, what we want to let go, what to nourish/plant, and what is here to stay.

# **Lay-Led Communities of Faith**

Jody Maltby led a conversation that considered the changing context of communities of faith and our current processes and oversight for lay-led congregations. It focused on the General Council Executive proposal, GCE06 *Ministry Leadership to meet the needs of the church in the 2020s*. The discussions around the proposal revealed that this is an issue that needs to be addressed in our church. The proposal asked, might the question we are grappling with be: How do we create a structure of placing personnel that does not create harm?

She spoke about lay-led congregations in Shining Waters, what types of congregations have lay leaders, as well as the strengths in a lay-led congregation and the challenges in a lay-led congregation.

She also spoke about Licensed Lay Worship Leaders, Congregational Designated Ministry and Pastoral Charge Supervisors. The Pastoral Relations Commission trains Licensed Lay Worship Leaders and appoints Pastoral Charge Supervisors. The

Communities of Faith Commission has oversight of congregations. Increasingly there is a rise in lay-led congregations that may be more permanent than in the past.

The 44th General Council also encourages regional councils to explore and implement ways that support rural and other struggling ministries in The United Church of Canada and that what is done at the regional councils be shared back to the national church because we have work to do as a whole church that honours a diversity of faithful forms of leadership.

The meeting took a 10-minute break.

# **Equity Project Goal and Plan**

Paul Stott led a conversation about highlighting the equity lens for the Living Faith Story of congregations.

He spoke about encouraging equity considerations to be included in the development of the Living Faith Stories.

- Does it contain an equity statement reflective of the congregation's current practice and future vision?
- How would a LGBTQ2S+ minister read it?
- How would a differently-abled minister read it?
- How would a racialized minister read it?
- How would a female minister read it?

# **Intentional Interim Ministry**

Diane Matheson-Jimenez and Chris Bennett led a conversation about how we can be more deliberate with our resources, support, and networking for those engaged in the intentional interim ministry process. They shared an overview of how churches move through transition. Is there interest in a shared working group to review the situation and recommend directions?

Some of the questions addressed were:

What are the resources needed?

What do you see as your accountability relative to intentional interim ministry?

What do you see as a vision/opportunity?

What are we going to do about it?

It was suggested to take this away to our respective commissions and create a small working group to look at these questions as a way to support intentional interim ministry.

Some of the comments/thoughts given:

- a great tool, are we using it as a region as effectively as we could to be more strategic in the way we employ intentional interim ministers?
- there is a need to be more prescriptive as to how intentional interim ministry is used.
- there will come a time when intentional interim ministry will become inaccessible to the congregations that desperately need it. If this is a tool we value, how are we going to remedy that?

- there usually is a shortage of trained intentional interim ministers although currently we do have enough, but it could be because of a lack of energy for congregations to create a transition team, etc.
- there are patterns, so we perhaps need resources to support congregations more as they go through transition.

# **Supporting Communities of Faith as They Close**

Todd McDonald led a conversation about support for communities of faith, (both ministry personnel and lay leaders) as they close, based on the story of Minesing United Church, including: naming attitudes/stigma and isolation that they face, challenges of dealing with practical things (assets); naming legacy, telling their story, celebrating history, planting seeds for the future, transitioning members. What's our experience? How can we help? What kind of care and accompaniment can we offer? Can we identify best practices?

Learn from endings; both good endings and those that didn't go well. Calin Lau shared a story of ending well, and the learnings from that. Dee Lawrence spoke about an ending that did not go well and those learnings.

The meeting shared with each other what about the stories of endings filled them with thanksgiving; and what new directions they hope for when considering churches that are closing.

Donna Bowman-Woodall invited people to share a gratitude and offered a blessing prayer for lunch.

The Commission decided to table this motion in order to do due diligence and request the input of United Property Resource Corp. (UPRC) on the matter of the sale of the building and manse.

Cheltenham United Church also presented a legacy plan and asked for approval of the disbursement of 10% of any remaining financial and property-related assets as follows:

Canadian Foodgrains Bank (15%)

Bethel Hospice (10%)

Caledon Community Services (15%)

Meals on Wheels (20%)

S.H.A.R.E (10%)

Headwaters Health Care Centre, Orangeville (6%)

Brampton Civic Hospital (6%)

Georgetown Hospital (6%)

Boston Mills Cemetery (7%)

The Commission decided to table this motion pending the decision on the disposition of the church building and manse.

The Commission did agree in principle with Cheltenham United Church's legacy plan as presented, with any final decision pending on the disposition of the property.

#### Lay Forums

• Debrief October 19 event

Susie Henderson gave some information and feedback on the lay reps' forum that was held on October 19<sup>th</sup>. There were 51 registered, and 47 attended. The material shared at the forum is on the Shining Waters website along with some notes.

Susie asked for feedback and thoughts for future forums from commission members.

- some people don't have internet, so include a phone number for those folks when referring people to the website;
- felt people wanted to talk to each other and connect as well as get information;
- perhaps have a forum without much agenda and more mutual conversation;
- some smaller congregations who don't have a regional rep are not engaged in the same way; hard to design something like this that encompasses all sizes and types of congregations; perhaps design something just for the smaller congregations
- needs to be a safe place for lay reps from those churches that are thriving and doing exciting things, so they can talk about what's working and not without judgment from communities of faith that are struggling. How do we create space for clusters based on what are the real needs of your community at this time?

#### **New Business**

• Early Warning Indicators of Congregational Financial Instability – offer from SPHAERA RESEARCH | HALO CANADA PROJECT Halo is a data collection project and reached out to us about doing a study around early warning signs, financial indicators, of congregations that are closing. The cost is \$3,000 for the report. Is this something that we are interested in exploring? would it be of use to us? What would we do with the information and how would we respond? They have done such a report for the Anglican church. Susie will get some more information and will see what the Anglican report looks like.

- Structures were built for a time when volunteers were plentiful –volunteer workforce is now depleted
- In small places the congregation is the council (and everything else)
- Wonder about how accountability is maintained when processes are less formal?
- Recruiting new people is a challenge
- Roles are just swapped between the same people
- Scarcity of volunteers in the charity sector as a whole
- Feels like online meetings could be a positive change if they are well done
- There are many, many avenues of communication these days how does a congregation decide which to use?
- Governance in a Nutshell: This is a PowerPoint that is a compilation around the questions of governance; it could take the form of a workshop; or we could create a resource page on our website.
- Future Governance Task Group Meetings: The group will meet the second Wednesday of the month at 1:30 p.m.; February 8, April 12, September 13, November 8, 2023.

The Commission was invited to comment and give feedback. Gloria acknowledged and thanked the task group for their work.

# **SPHAERA Research** - update (*Susie*)

At the October meeting the Commission heard about the proposal from SPHAERA RESEARCH | HALO CANADA PROJECT on Early Warning Indicators of Congregational Financial Instability. Halo is a data collection project and reached out to us about doing a study around early warning signs, financial indicators, of congregations that are closing.

As a follow-up to the discussion and questions at last month's meeting, Susie got further information. One of the Commission's questions was, what is required from us for this research and what is required from congregations. SPHAERA would require a list of regional congregations, their addresses (including postal code), and ideally their CRA business number if available. SPHAERA would then request T3010 information directly from CRA for the congregations listed.

They have done this work for the Anglicans and when asked, indicated they will reach out to their contacts in the Anglican church to see if they are comfortable sharing with us. Susie reached out as well to her contacts in the Anglican church but they didn't have any information on the project.

The cost is \$3,000 and the question was posed, what will we do with the study? Is any of this work being done at the national church through statistics? There is some analysis of data that can be done on an individual basis, from statistics and Church Hub.

Congregations are engaging with Kindred Works, and Shining Waters gets asked by congregations as to what they do in the meantime until they see some income on their development. It is a big conversation.

<u>MOTION</u> by Patti Rodgers / Calin Lau that the Communities of Faith Commission of Shining Waters Regional Council not pursue the SAEPHRA proposal at this time and thank them for their interest.

# Regional Meeting Planning Team (Jody)

The Executive is inviting the four commissions to name someone to assist the team in planning the annual regional council meeting, particularly around educational and community-building pieces. It is not a hands-on team, just planning, and would be three to four online meetings over the next few months. Eric Nyarko agreed to be part of that planning team.

The meeting took an all-purpose break.

Chris Bennett joined the meeting and resumed the Chair.

# **Communities of Faith Updates:**

# • North York Korean (*Diane*)

We will be getting a report from Rev. Richard Choe; it will likely ask this Commission to reconsider a motion made that indicated that North York Korean could not enter into a search process until they have completed a significant amount of work. Richard feels a lot of work has been done and his report may be asking for a motion giving permission for North York Korean to enter into a search for a six-month supply position in order to give them some stability to help them look forward but also to not give them too much leeway. The report will be circulated to the Commission when received and the request may come to the Commission as an email vote.

#### • St. Paul's Brampton (*Diane*)

Jody and Diane will be meeting with this congregation on November 21st to bring the decisions of the Review Committee; this commission granted an extension to 2023 for a final report.

#### • Keswick (*Jody*)

Jody is meeting with the Keswick Board November 17<sup>th</sup>. Diane and Jody have had conversations with them over the past few months; they are exploring their options for the future.

# • Countryside (*Jody*)

Next week Jody is meeting with the Countryside Board; they have been reaching out and exploring options.

We are probably going to be having more and more of these type of conversations with congregations over the next year or two. It speaks to prior conversations around how we use resources to support congregations as they are making these decisions, as they are exploring new ways to be viable, etc.

# • Bala-Port Carling (*Diane*)

This pastoral charge had been under review and received the Review Committee's decisions in September and work has begun to move forward.

Port Carling United Church is having to work harder to work through the governance work that needs to happen, and the need to have a solid communication plan, so the Review Committee decided to call on Credence & Co. to do some restorative work. Credence has submitted a proposal outlining the work they could do and the fees. Diane reviewed the proposal with the Commission and noted that the fees do not come out of this Commission's budget. She also talked about the possible good outcome of the work, and the potential consequences.

The Commission had questions and discussions on the proposal and the work.

<u>MOTION</u> by Gloria Tozek / Carolyn Harding that the Communities of Faith Commission of Shining Waters Regional Council approve the expenditure of funds, to a maximum of \$17 000, from the appropriate line of the regional council budget as directed by the Finance Administrator Janet MacDonald, for the proposal from Credence and Co. on Port Carling United Church.

## **Looking towards 2023**

How do we proactively support ministries throughout our region? How do we try to create sustainable ministries in every way?

What are the resources that we have available to us? How do we help congregations make some of the necessary choices; what tools and supports can we give from this Commission? How do we try to support what we know are conversations coming up with congregations?

# Theology of property

How do we create a conversation that is supportive and positive but also recognizes some of the truths about what the property represents, that the property is something that is held in trust for the larger church and is intended for the broader intentions of ministry throughout the region, and how does that knowledge get brought into the conversations more clearly across the region?

Last Spring out of this conversation, Jody was tasked with broadening this to include the wider church because it is not just our region that is wrestling with these property conversations. She reported that they approached General Council in the Fall to see

whether we could partner on a conversation and Jody is meeting next week with Sarah Charters, Executive Minister for philanthropy, and Jennifer Janzen-Ball, Executive Minister around theology and faith, to talk about whether there is a possibility of partnership that would also include the National Indigenous Church, Kindred Works, and opening it to the other regions, and including our folks.

Jody mentioned that what seems key is that first we have to understand the theology that informed the policy as it currently is, which really does give that ownership role to individual congregations in partnership with the regional council, and we need to name that, and then we need to name what is our theology of property, and we need to formalize that nationally, and then regions can use that to inform their decision-making.

#### **Policy**

Can we consider looking at our policy on the disposition of sale of funds to include a fund for our community ministries? One of the things named currently in the policy is that surplus from amalgamations, and funds recognized when a congregation sells their property but are continuing, are funds that are available to be granted by the Grants and Mission Support Committee. If we get too explicit in a policy, we would be doing that Committee's work.
