#### **Property Conversation** Tom MacNeil, Gloria Tozek, Jody Maltby

In September, we asked the Commission to think about the theological understanding that may have informed our current policies and practices relating to property, and how this theology does or does not help us to live into our commitment, to be in right relationship with Indigenous peoples.

- how the communities of Faith Commission can support congregations to include some theological reflection when they're considering property questions
- there is a real tension between what we want to do today in terms of our theology, and in terms of having a view of property that's more aligned with the Leviticus readings
- there are some power relationships here that need to be disruptive, and we struggle with that because we're also beneficiaries of it, and can be, the source of good for us
- there are resources embedded in buildings that are critical to our future as a region and as a church
- shifting the point of view from power over to power with
- if we sell a church and it goes to low-cost housing, or it becomes a community center of some sort, that's just as in line with the Church's mission as keeping the cross on the front and keeping United church on a sign there somewhere
- it is also a matter of empowerment, so how can we empower the communities of faith that have the power to make a decision that they can see the benefit of the communities or wider communities, and empower them to think and act on behalf of the wider church and the wider community, and the whole of creation.

We offer the following as a way to begin the conversation:

- 1. As you are preparing to make a decision regarding property how will you express your congregation's living faith story?
- 2. Think about some stories and images from the Bible that are reflective of how we in our faith are called to think about property. How do they inform your conversation?
- 3. How can we honour our purpose as outlined in The Manual: The community of faith

- a) lives in covenant with the regional council with mutual responsibilities for the life and mission of the community of faith, and for fulfilling its responsibilities under the covenant:
- b) regularly self-assesses its ministry and files the self-assessment report with the regional council;
- c) joins the hearts, voices, and resources of the community to witness to the gospel and vision of Jesus for a compassionate and just society, both in Canada and around the world;
- d) engages in local, regional, national, and global initiatives and partnerships (community, ecumenical, and interfaith) for ministry, mission, and justice work;
- e) ministers with children and youth and young adults;
- f) honours and lives into intercultural mission and ministry; and
- g) lives in covenant with Mother Earth and All My Relations in the Earth community.

(The United Church Manual, section B.2.1.1)

- 4. How can we live into the United Church's commitment to:
  - 1) living in right relations with Indigenous peoples, and responding positively and meaningfully to the Truth and Reconciliation Commission Calls to Action and the Caretakers of Our Indigenous Circle Calls to the Church;
  - 2) becoming an anti-racist church (declaration of the Commissioners of the 43rd General Council, October 24, 2020);
  - 3) welcoming people of all ages, abilities, races, sexual orientations and gender identities, and any other forms of marginalization into, and removing barriers to, the life, work and leadership of the Region and our communities of faith.
- probably no one's going to hit every one of those with every decision although, maybe one or two of those are something that a congregation might be able to elaborate on
- the whole idea is to just start them thinking about something rather than money
- where is the greatest impact that a congregation can make?

#### The Commission as a whole offered the following feedback

Ownership is something that we struggle with, especially in light of some of the obligations and commitments that we are making, and should make, or have made with respect to our indigenous siblings.

How to get it to become part of our services as we go into those conversations.

Who owns the property? The trustees are the hold the property in trust for the congregation, for so long as the congregation continues to exist, if and when a congregation cease to exist the property, it reverts to the United Church of Canada. So, while a congregation exists. they are the beneficial owners of the property, but they can't make decisions without approval of the Regional Council. Before any congregation can move forward with the property in whatever direction the Regional Council, must give approval, unless the decision that they're making is under the thresholds that we have set. So, for example, if a renovation is left less than \$50,000, it does not require regional approval. If a lease is less than \$50,000 or not for exclusive use, it does not require regional approval, but for the most part any decision with respect to property does require regional approval, if a congregation proceeds with a decision without getting the proper regional approval, then, and if there is a problem as a result of that decision, then both the trustees and the governing body individuals on those could be personally liable. If there is a problem that leads to any kind of litigation.

Try to encourage people to actually begin by looking at vision and their call before actually getting into some of the legalese aspects of it.

There is within our property policy a stipulation that a percentage from the sale of property will go to a fund that is directed towards indigenous ministries.

Are these questions that we would be offering to a congregation who's considering making some property decisions? Or is this something that we're going to be offering generally to people within the region? - these were questions that we would be offering to communities of faith as they were approaching a sale or a lease.

How do we make this information accessible to those lay led congregations?

We might want to put in a few suggestions of stories and images like give examples for people to go to.

#### Forest Grove United Church, North York

Forest Grove consulted 3 real estate agents, 2 of whom recommended going with the open bid process for this particular sale because of the nature of the market. When there is surplus from an amalgamation, it comes to the regional council and is distributed through our granting process.

#### **Listening Plan Lay Led Congregations** Diane Matheson

Diane then discussed their proposal to engage with lay-led congregations to understand their needs and share resources. They plan to start this outreach after Easter, with the intention of fostering relationships and learning from the experiences of these congregations.

**Purpose behind this proposal:** In October 2023, the Pastoral Relations Commission and the Communities of Faith Commission recognized that lay led congregations may become more prevalent in Shining Waters Regional Council. The Commissions jointly asked for a listening process with the current lay led congregations and their pastoral charge supervisors to find out how best to support lay led congregations into the future.

Goal: To create a process for listening that builds trusting relationship between the regional council and lay led congregations in order to assess the needs of those communities of faith. Pastoral Charge Supervisor can help provide support for the connection with lay led congregations. The listening process can be informed by an Appreciative Inquiry approach which focuses the listening for those things that are working well, and seek to learn from and enhance them. It will be important for lay led congregations to know that the intention is to listening and learn from those communities of faith.

#### **Community of Faith Updates**

#### <u>Forest Grove & Jubilee</u> – amalgamation agreement

An amalgamation agreement has been received from Forest Grove and Jubilee. This relationship is about growth, connections within the community and possibilities. March 31<sup>st</sup>, 2024 date of amalgamation. This agreement was submitted previously in January for feedback and the commission was supportive of this direction.

The commission supports this amalgamation going forward as scheduled but has also identified a number of learnings to inform our decision-making process for future requests. It would be helpful to have more data about the congregations' income and assets to understand the potential for ongoing viability of a newly amalgamated congregation. The commission voiced concerns about decisions that have been made in several instances related to allocation of funds from the sale of property, in particular the use of proceeds from the sale of a church building to pay a minister's compensation. While congregations can access interest from a manse fund to pay a minister's compensation, they can't access capital in that fund for this purpose. This discrepancy in how we allow access to capital from the sale of property may create inequity, particularly between larger urban churches and smaller rural ones.

The commission also discussed the importance of regular check-ins and the possibility of reallocating funds if things don't go as planned.

The commission asked that this be an item on the agenda of the next meeting to allow for a fuller exploration of these issues. These are systemic concerns that should be separated from the particular experience of considering the request from Forest Grove and Jubilee.

Eric Nyarko joined the meeting

The meeting took an all-purpose break.

MOTION by Patti Rodgers / Tom MacNeil SW-CFC-2024-02-21-03 that the Communities of Faith Commission of Shining Waters Regional Council approve the amalgamation agreement between Forest Grove United Church and Jubilee United Church with March 31st, 2024 being the date of amalgamation with the understanding that \$6,197,319 is restricted to be used over ten years as outlined in the agreement. The congregation will provide an update every three years demonstrating that the congregation continues to be active and viable or an alternate plan for the use of those funds. Should the congregation cease to function, remaining restricted funds will revert to Shining Waters Regional Council to support other communities of faith.

#### **Review of Property Policy** *Jody Maltby*

The Commission discussed the financial implications of selling properties and using inherited capital, with Jody clarifying that there are no restrictions on how the congregation can use the inherited money, unless there was a former presbytery restriction. They also discussed the differences in financial proposals between congregations that choose to amalgamate and those that choose to sell their properties separately, noting that amalgamating congregations have more financial flexibility. The Commission agreed to continue discussing and refining their policies, with a focus on decentralizing decision making and resources to better serve communities of faith. The need to review a policy and its effectiveness in meeting their needs was also recognized, with the Commission agreeing to involve Jody Maltby, Harry Ramsaran, Chris Bennett in the review process.

Lastly, they touched on the ongoing work of the community ministry, particularly in relation to funding.

Tay discussed the Innovative Ministry Center's mission, its founding, and its future plans. He highlighted the center's role in supporting digital communications, collaborations, and the United Church of Canada's global mission. Tay also discussed the challenges posed by the COVID-19 pandemic, the rise of the "VUCA" business model, and the resulting vocational leadership crisis in the church. Furthermore, he mentioned the center's growth, its plans to create an online environment for communities of faithful purpose, and the development of a robust ecosystem through new partnerships. The discussion also touched on the concept of church, the use of AI-related tools, and the potential of virtual platforms like Church X to augment and extend traditional church ministry. Chris raised concerns about the potential replacement of traditional church ministry with Church X. Tay Moss left the meeting.

#### **CFC Budget** *Jody Maltby*

Jody discussed the budget for the Commission, which is \$35,000 per year. In reviewing spending in 2023 and 2024 to date, we are not making full use of the funds available. Jody emphasized the need to follow up on the strategic visioning process initiated in 2022, suggesting a reallocation of funds to support broader congregational development. Chris expressed concern about the effectiveness of the budget execution and suggested that it could be used for church cluster development. The \$35,000.00 is committed for this year, and it's in the budget for 2025 as well.

- 1. related to poverty and homelessness, and taking an action on that
- 2. related to communication between that Commission as the Social and Ecological Justice Commission and local communities of faith, and how to strengthen that relationship
- 3. originating from Grace United, Barrie related to calling on the General Council to support Broadview Magazine.

The following proposals will be heard at the Regional Meeting on Saturday June 8<sup>th</sup>, 2024, although there will be a town hall to discuss these proposal on Wednesday May 29<sup>th</sup>, 2024 along with the budget.

- 1. Dalston Crown Hill, United Church. Calling on the Regional Council to distribute \$4,000 to every pastoral charge within the Regional Council as a sign of support and recognition of the struggles that congregations are facing.
- 2. Fairlawn Avenue United Church in Toronto, calling on the Regional Council to develop strategy, for how we can support, congregate churches in the GTA, who are rich in property assets, but perhaps struggling in their financial assets to support their ministry and their communities.
- 3. Executive asking that we table and pause those 2 proposals to allow our Finance Committee to do a full understanding of our current commitments.

#### <u>Update on Credence & Co Workshop</u> Eun-Joo Park

Eun-Joo gave an update on registration for the May 23<sup>rd</sup> workshop, which is an overview of understanding conflict and her plans for follow up sessions from the Communities of Faith task groups.

July 1st, 2024 is the proposed date of amalgamation. The commission asked questions for follow up and the commission was supportive of this direction. It will be approved at Congregational meetings, and then it will come back in June for final approval from the Commission.

#### Collier Street United Church, Barrie – Jody Maltby

Collier Street United Church, has been engaging with Trinity Centers Foundation to pursue a possible development plan, and as per our property policy, they need to get approval of the contract. When a congregation is working with an external developer, the commission may consult with Kindred Works because they are the development arm of the United Church.

The commission agreed that Collier St may proceed with the contract but also offer the following questions for consideration. The commission felt these are not reasons to withhold approval but clarification might strengthen the contract for CSUC:

- In item 2 it states that the agreement does not create a partnership but the terms and conditions at the end of the document refer to a partnership. Is CSUC comfortable that they understand the nature of the relationship?
- In item 7c, what information is going to be provided to TCF regarding denominational decision-makers?
- In item 12, is it acceptable to CSUC that TCF will continue to own the intellectual property even though CSUC is paying for it? Is there an understanding of what will happen if CSUC decides not to proceed beyond phase 2 of the project?
- CSUC is encouraged to ask for a copy of TCF's Code of Ethics and proof on insurance.

## WEST HILL UNITED CHURCH, PROPOSAL FOR THE DISPOSITION OF FUNDS

Deb and John discussed the financial challenges and strategies for maintaining West Hill's viability, including the need for a return on investment and cost-cutting measures. They also clarified the conditions for the renewal of the vendor buyback mortgage and addressed questions about the need for separate leadership positions.

John McKechnie, Deb Ellis, Mike Lawrie (WHUC Board Chair), Dan Cooperstock, Annie DiPede left the meeting

The decision to recruit from a global pool was influenced by language guidelines and West Hill's global aspirations, although concerns were raised about the feasibility of finding suitable candidates for these part-time roles. They discussed a vendor take back mortgage from 2020 with a principal amount of \$2,000,650. They reviewed the mortgage's status, noting that the principal balance remained at \$2 million, with a rate of 6.5%, and was due for renegotiation in 2025. The commission is still unsure of the full financial picture for the congregation. Jody will follow up to request a budget for 2024 and 2025, and ask them to fill out the financial viability tool used by the Pastoral Relations Commission. The commission discussed whether it would be appropriate to ask West Hill to provide the 10% contribution to the Indigenous Ministries Fund and renew the mortgage for a three-year term during which they would continue to benefit from the interest income. At the end of the three-years, the commission and West Hill could consider again whether it might be possible to provide the additional 10% contribution. The commission will revisit this discussion after receiving the additional financial documents.

<u>UPDATE ON STAFFING AT THE REGION LEVEL</u> – *Diane Matheson-Jimenez* A discussion was had around how we can maximize efficiency and efficacy. Due to our Financial Administrator retirement, Jody is going to assume her duties, supported by a full-time Accounting Assistant/Bookkeeper. Jody will continue to support CoF during property issues as well as the financial implications. Jody will continue as staff lead and Diane will now provide support and supervision to the program staff in the work of supporting Communities of Faith and Pastoral Relations. We are in the process of hining one full time, permanent program staff person, and one temporary staff person.

#### **Community of Faith Updates**

#### WESTMOUNT UNITED CHURCH, ORILLIA – Jody Maltby

A member of the council has filed an appeal against the Communities of Faith Commission decision to approve the request from the council and trustee of Westmount to list their property. The appellant has until September 23<sup>rd</sup> to provide a statement of argument; the CFC will have the opportunity to provide a response. We will retain legal counsel to assist. The General Council Judicial Committee decides whether the appellant has met the test for an appeal and whether or not an appeal will be heard.

Regarding the listing, we can proceed with sale, unless we or Westmount Council decide that we're going to pause pending the appeal. The commission expressed concern that delaying the sale will have a negative impact on the congregation. And it opens both Westmount and the Commission up to some potential liability. The commission chose not to pause the sale at this time.

The Region has been asked to hold the Congregational Meeting set for Sunday September 29<sup>th</sup>, 2024 to talk about future steps. During this meeting, they will be advised to consider whether or not it is still a viable option to proceed with an ecumenical shared ministry or whether the congregation should make the decision to close. The commission has concerns about whether the congregation is still strong enough to proceed with the shared ministry. If the congregation wishes to proceed with that path, a formal assessment of viability may be required. The commission asked questions for follow up but in general was supportive of this path forward.

#### EBENEZER UNITED CHURCH, MARKHAM – Eun-Joo Park.

A request has been received from Ebenezer United Church, Markham to have a listening team. This is a process that has been well-received in other congregations. The team will meet separately with the minister, the governing body, and with the Ministry Personnel Committee. A number of documents including annual reports and financial statements will be shared with the team to provide a full picture of the life and ministry of the congregation. The team will then offer some recommendations back to the congregation for consideration. This is not a formal process; unlike a congregational review, the recommendations are offered for consideration without any requirement that they be adopted. The team will consist of Krista Moore, Tom MacNeil, Isaac Kamta and Eun-Joo Park.

<u>COLLIER STREET UNITED CHURCH, BARIE</u> – *Diane Matheson- Jimenez* Previously we have been referring to the group that Collier has signed a memorandum of agreement with as Trinity Centers foundation. Trinity Centers has rebranded and are now called Relèven. The theme of the town hall about development possibilities at Collier Street was reimaging our space. Relèven came up with 3 possible choices to move forward and invited members of the community to provide input. There were 4 questions that those who participated were asked to consider.

- ✓ What role does Collier United have in addressing opportunities and challenges in Barrie?
- ✓ What could the space be used for?
- ✓ What have been barriers to finding the kind of space you need to access in the community?
- ✓ Who needs to be at the table?

The information will be gathered, given back to the leadership team. The leadership team will digest that and present it to the community of faith.

#### **ST LUKE'S, TORONTO** – *Jody Maltby*

St Luke's is a congregation that has signed an agreement with Kindred Works and United Property Resource Corporation to develop their property. They have had some financial struggles and a recommendation was made to the Executive to approve a \$50,000.00 loan to them, so they could continue to have some ministry following the conclusion of their IIM. Therefore, it is important that this development project be successful so it can provide an income source that will help ensure the sustainability of the congregation going forward. Jody has been working with Kindred Works to ensure the costs of the building are covered. St Luke's has agreed that their property is going to come into the Regional Trust and the region will become the beneficial owner. Eun-Joo has been working closely with the congregation to develop a realistic ministry plan and budget to support it. St. Luke's will receive the income from the development, when it becomes income producing, that they need in order to be viable, vital, and grow, but a portion of that income will also be used to pay back the costs of managing the building incurred by Kindred Works during this interim period, and also the \$50,000.00 loan.

#### **DEWI SANT UNITED CHURCH, TORONTO** – *Jody Maltby*

Anytime a congregation sells a property the commission approves the agreement of purchase and sale. An e-vote will be going out in the near future and it will be a tight turnaround.

#### Welcome, Constituting the Meeting and Worship

Chris Bennett welcomed everyone to the meeting. Lawrence Nyarko gave an acknowledgement of the land and led a time of worship. There was a time of introductions.

<u>Lay Led Congregation Listening Process</u> - *Diane Matheson-Jimenez and Todd McDonald*As a result of the presentation at the 2023 joint commission, a listening process was initiated for our lay-led congregations. Commission members shared their assumptions about these congregations. Todd and Diane kickstarted the listening process by meeting with the Pastoral Charge Supervisors from five lay-led congregations, where they shared and discussed three key questions.

- 1. What is the biggest challenge or need for the lay led congregations?
- 2. What are the success stories from your perspective as Pastoral Charge Supervisor?
- 3. Are there resources that the regional council could provide you

A word cloud of their responses was shared, sparking a discussion within the group about which words stood out the most. An invitation was then extended to visit the five lay-led congregations, and two of them graciously welcomed them. Their responses were shared with the commission, leading to a discussion among its members. The commission was subsequently invited to respond to the following question "What do our commissions need to do to keep working at our relationship with lay led congregations?" Responses below were shared

- Develop a toolkit to guide lay-led congregations toward thriving.
- Place greater emphasis on the pastoral aspect across all community forms.
- Organize pulpit exchanges between ministers or leaders of congregations.
- Collaborate with lay-led congregations to celebrate their strengths and gifts.
- Engage in deep listening to understand the genuine concerns and motivations of lay-led congregations.
- Utilize process points of contact to facilitate connections when congregations seek support and opportunities.
- Encourage positive interactions between Regional Council and communities of faith.
- Acknowledge their own visions of discipleship.
- Foster more frequent communication with lay-led congregations, either in person or by phone, to determine what support they need to thrive.
- Simplify lay leadership training.
- Lead efforts to create clusters where lay-led congregations can support one another.
- Continue the listening process by including a lay member from each commission on the listening team.
- Focus on support, education, sharing hope and vision, and building trust.
- Solicit ideas from lay-led congregations for enhancing community.
- Ask questions such as: "Where are you in normal times?" "What do you contribute to congregational life?" and "What do you need or want?"
- Increase communication among all parties to break down mistrust.
- Maintain connections with Pastoral Charge Supervisors and provide ongoing support.

Liz Mackenzie joined the meeting.

#### Assets During Change - Jody Maltby and Chris Bennett

Jody highlighted some of the commitments embedded in the regional property policy. The Communities of Faith Commission is dedicated to making decisions that foster healthy and thriving communities of faith, advancing right relations with, and justice for, Indigenous peoples promoting a more equitable distribution of resources. Jody spoke about how recent decisions have highlighted possible inequities related to property sales depending on the reason for the sale, for example the difference between when a congregation is amalgamating or will continue to exist without property. Jody and Chris also shared some of the work the commission has been doing around theologies of property and the possibility of offering questions for congregations to consider when making property decisions. It was also noted that the United Property Resource Corporation and Kindred Works are being intentional in identifying and separating their roles. UPRC is available as a resource to any region or congregation looking for support making decisions about property while KW works with regions or congregations to develop property for affordable housing.

The meeting took a 10-minute break.

#### **Equity Goal Project Updates** - *Liz Mackenzie*

The Pastoral Relations (PR) commission is currently developing a negotiation handbook through the Equity Task Group to assist with negotiations. They are also focused on identifying and

addressing any inequities affecting equity-seeking ministry personnel in calls or appointments. Additionally, the PR Liaison, who collaborates with search committees, is receiving training on equity-related issues.

Jody provided an update on the members of the Ad-Hoc Committee and their current progress. She encouraged both commissions to engage in the consultation and to motivate others to participate as well.

# <u>Pastoral Relations Commission: Ordination, Commissioning, and Admission Policy</u> - Todd McDonald

The Pastoral Relations Commission has passed a new Ordination, Commissioning and Admission Policy. The United Church of Canada admits people into the Order of Ministry. The Manual (H.4.8) states, "b) confirmation that a covenantal relationship is in place with a community of faith or offer of employment to a paid accountable/recognized ministry, as determined by the regional council" as a standard that must be met for ordination, commissioning or admission. This policy outlines the requirements for the approval of a provisional call or appointment for ordination or commissioning as determined by the SWRC.

## The policy states that:

- i. The coveanted relationship must be for at least 6 months.
- ii. The covenanted relationship must be at least 14 hours per week
- iii. And finally, must not fill a gap for an incumbent minister on leave.

Given that the sale proceeds were initially expected to be significantly higher (with the first offer being \$5,850,000), does this create an opportunity to reconsider the allocated amount in light of the lower sale price? In particular, will the new price provide sufficient funds to cover the commitments in the amalgamation

agreement and will there by any surplus funds to come to the regional council? Jody will have a conversation with Ron Ewart.

Shawn emphasized the significance of structuring faith formation within the regional councils and its alignment with their mission. She stressed the importance of nurturing and supporting faith formation within faith communities and noted a shift from a hands-on, passion-driven approach to one that focuses on resourcing and fostering connections.

## DISCUSSION OF PRIORITY SETTING WORK

A document was shared that outlines the key discussions from 2024, work completed to date, a summary of all decisions made, and the budget process, including the strategic direction, goals, and the 2023 budget.

Chris and Jody discussed the commission's budget and priorities. Jody shared that they had spent just under \$7,000 of their \$35,000 budget, primarily on direct support to congregations. She also highlighted the various projects the commission has been involved in, such as supporting lay-led congregations, providing education and support for lay leaders, and working with the new fund for community ministries. Jody mentioned the upcoming survey to identify the regional council's funding and ministry priorities for the next year prepared by the ad-hoc committee formed in direction from the June Regional Meeting. Eun-Joo pointed out a discrepancy in the budget, where a cost attributed to CFC was mistakenly included in the PRC's budget. The commission agreed to reallocate this cost to the CFC. Jody will follow up.

The needs for funds to support collaborative ministry activities and events was discussed. It was suggested that staff be empowered to approve fund usage up to a certain amount, based on specific criteria. Based on discussion in this meeting, staff will provide direction and objectives for the budget, with funding allocated to demonstrate the importance of these objectives. The commission also discussed the importance of fostering collaboration among congregations and improving communication to prevent issues from escalating. It was suggested that the regional council could enhance its understanding of issues by reviewing annual reports.

The challenges of communication and connection following the loss of Presbyteries was named.

## SELECTION PROCESS FOR YOUTH FORUM DELEGATES

On behalf of Shawn Redden, Justice and Faith Formation Minister, Jody discussed the selection process for youth forum delegates for General Council 45 which will occur next summer. The General Council is encouraging us to emphasize the importance of racial diversity. Jody recommended forming a short-term task group to review applications and provide recommendations for the February meeting. Tom MacNeil and Sandra Nottegar volunteered to be part of the group.

# **Community of Faith Updates**

#### **BAYVIEW UNITED CHURCH** – *Jody Maltby*

Jody provided an update on the sale of the Bayview United Church property as part of the amalgamation between Cummer Ave and Bayview United Churches. The sale has encountered challenges due to a long-term land lease to which has impacted the buyer's ability to obtain financing. This has resulted in a reduced purchase price. The regional council has agreed to a Vendor Take Back mortgage and interest payments on this mean that the total payment will be close to the original selling price.

The listening team, comprising Krista Moore, Tom MacNeil, Isaac Kamta, and Eun-Joo Park, met with Ebenezer United Church on Saturday, November 9th, 2024. There is one more person to speak with, after which a recommendation will be presented to the commission at the January meeting.
