Jody shared next steps for the team which is to first post the report on the SW website on the Finance page. It will also we sent out as part of "Currents" since there are a lot of people waiting to see it. The report has a fairly large impact on at least 3 Commissions and Committees (CFC, Mission Grants Ctte, and the Finance Ctte) and those 3 will be meeting in June to discuss and be prepared for it. Finally, the report will come to the Regional Council Meeting (RCM) in October 2025. There was a suggestion that perhaps there might be a Town Hall Meeting prior to the RCM to give people an opportunity to ask questions. Once the Ad Hoc Committee reports to the RCM, it is unlikely that they will be meeting again, as their work will be complete.

Executive thanked Sarah, Allyce and the whole Ad Hoc Committee for their diligent work on the report.

**REMOVAL OF JANET MACDONALD AS SIGNING AUTHORITY AS OF JUNE 30, 2025**It is with regret that the Executive pass the following motion and they wish Janet the best in her new chapter in life.

## AFFIRMING AND EQUITY WORK

Executive welcomed Kim Uyede-Kai, CoF and Pastoral Relations Minister; Intercultural Diversity, Anti-Racism and Right Relations Minister, to the meeting.

Peter gave a background of equity and affirming work in the region, sharing that there are questions that are an invitation for us both as staff and the regional council to remind ourselves where we are around equity and affirming work. He also indicated that Eun-Joo Park, Pastoral Relations and Community of Faith Minister, shared that the Pastoral Relations Commission (PRC) asked the question 'what was our current and future vision of equity and affirming work?'

After discussing this topic, the suggestion was made that perhaps a small task group could be created with the staff support from Shawn Redden (Justice and Faith Formation Minister), for affirming work in our region.

MOTION by Peter Hartmans/Allan Holditch SW EXEC 2025-06-03-08 That the Shining Waters Regional Council Executive approve of an Affirming Working Group supported by the Minister for Justice and Faith Formation (Shawn Redden). CARRIED

Kim shared that the formation of the Intercultural Diversity Commission was an act of equity in and of itself but the Commission is not a program. Kim agreed with Lynella that there needs to be some kind of educational program to re-educate people about equity and to help people understand the depth and breadth of what equity is in all our actions and ways.

After Executive discussed equity, it was decided that this topic will be on the agenda at the September meeting. Peter will write Eun-Joo Park to discuss the Executive conversation so she can relay the information to the PRC.

The joint townhall also affords the opportunity to hear similar themes and struggles. Leaving it to the planning team, my sense is the event will have an opportunity for CSRC and SWRC to connect as separate regional councils too.
